

Consumption



• Region Gotland will act in favour for establishment of biogas as a fuel for vehicles according to following:

1. Leasing vehicles, when replacing cars biogas will always be considered as first choice if possible

2. Municipality owned vehicles, new and conversion of old. Biogas will always be considered as first choice if possible.

3. Procured transport services Biogas will always be considered as an option in procurements and shall be chosen if possible.

4. Stimulating the private car market Activities, campaigns, cooperation with the businesses and companies.



Production



- Securtity of supply Biogas must be available at all times
- Small or big scale?

Alternative suppliers are available. Region Gotland will support cooperation between the actors.

• Local production preferable Use for ferry transports may be limited, but cars, lorries, buses are suitable.



Distribution



- Region Gotland shall not own nor operate fuel stations
 - 1. The local biogas supplier operates the fuel station
 - 2. Cooperation with distributers of traditional fuels.
- Regional spreading of fuel stations Important for the households in order to inspirate them to invest in biogas cars but also for good service to the Municipal leasing cars.



Procurement




- Has to be completed according to the legislation and § LOU

Justification for the proposed strategy

- In accordance with the Environmental Programme for Gotland
- Other Municipalities in Sweden are active, expansion of the number of fuel stations and biogas production plants ongoing
- The Government has presented the goal to fase out fossil driven cars until 2030
- Gotland has good conditions for local biogas production
- Possibilities for EU funding for development of infrastructure.
